TENDER NOTICE

The Kenya Urban Roads Authority (KURA) is a State Corporation in the Ministry of Roads and Transport; established under the Kenya Roads Act, 2007 with the core mandate of Management, Development, Rehabilitation and Maintenance of National Urban Road Network.

As a leading Government Agency with the above mandate, KURA wishes to invite bids from eligible firms for various services to be funded through the Road Maintenance Levy as listed below:

Bidders may examine and obtain detailed tender documents during normal working hours,, from the Supply Chain Office at the Headquarters, situated at Barabara Plaza, Block D, Mazao Road - off South Airport Road, JKIA upon payment of a non-refundable fee of Kshs. 1,000 (Kenya Shillings One Thousand Only) for each document in form of a Bankers Cheque payable to the Kenya Urban Roads Authority. The same information may be accessed and downloaded from www.kura.go.ke/tenders and www.tenders.go.ke. Those who download the document from the website must forward their particulars immediately for recording at the Supply Chain Management Office on Ground floor Barabara plaza, Block D.

The bidders are expected to include the following in their bids:-

- ❖ Certified Copy of Certificate of incorporation;
- ❖ A copy of VALID Tax Compliance Certificate (Will be verified on the KRA TCC Checker);
- ❖ Certified Copy of RECENT CR12 form generated through the system -(6 months before opening date) from Registrar of Companies; failure to which the bidder shall be disqualified;
- ❖ Bidders shall sequentially serialize all pages for each tender document submitted; failure to which the bidder shall be disqualified;
- ❖ Other requirements are included in the tender document.

Note:

- All interested bidders are required to continually check the KURA website www.kura.go.ke/tenders for any tender addenda or clarification that may arise before the submission date.

The criteria of evaluation of bids

The criteria shall be as described in the tender document.

Scope

The description and scope of Services is as described in the tender documents.

Bid Validity

Prices quoted should include all taxes and must be expressed in Kenya Shillings and shall remain valid for a period of 210 days from the date of tender opening.

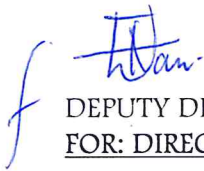
